

Requirements for manuscripts submitted to 'NURSING IN THE 21st CENTURY'

CHARACTERISTICS OF THE JOURNAL

„Nursing of the 21st century” publishes original, review and case articles on the theory and practice of nursing and related sciences. This regulations are prepared on the basis of the recommendations of Index Copernicus, „Uniform rules for articles submitted to medical journals” developed by the Committee of Editors of Medical Journals - Uniform Requirements for Manuscripts apply Submitted to Biomedical Journals: Writing and Editing for Biomedical Publication (Updated February 2006).

The journal is indexed in many databases, including: SCOPUS, ESCI – Web of Sciences, ERIH plus, CINAHL, Google Scholar, etc.

„Nursing of the 21st century” is published quarterly. The summaries and full articles are available online in electronic form – on the publisher's website: <http://www.piel21w.umlub.pl/> under the Creative Commons open license (CC BY 4.0 license).

GENERAL INFORMATION

Ethical requirements

Research conducted on humans must be carried out in accordance with the requirements of the Declaration of Helsinki, which should be indicated in the description of the research methodology. To carry out such paper, the authors must obtain the consent of the Local Committee for the Supervision of Research on Humans (Ethical Committee).

Without the consent of the relevant Ethics Committee, the article will be rejected at the editorial evaluation stage.

Liability

The editorial office tries to supervise the substantive side of the journal, but the Author is responsible for the content of the article. The Publisher and the Scientific Board of the Journal are not responsible for any consequences of any unreliability.

DETAILED INFORMATION – SUBMITTING MANUSCRIPTS FOR PUBLICATION

Sending the manuscripts to the Editorial Office

The editorial office of „Nursing of the 21st century” uses the **on-line platform** to register new articles:

Sending manuscripts to the editorial office is tantamount to a declaration that the article has not previously been published in other journals and has not been previously submitted to another editorial office. Submitting the article for publication is tantamount to the consent of all authors to its publication and a declaration that the authors had full access to all data in the study and take full responsibility for all the data and the accuracy of their analysis.

The corresponding author (as one of the co-authors) undertakes to provide all co-authors, along with their current e-mail addresses, telephone numbers and affiliation information.

E-mail addresses should be the addresses of the institution that the author is affiliated with.

Reviews

Typically, a minimum of two reviews are required for each manuscript (double blind review); additional reviews will be necessary if there are significant differences between the two reviews received. Ultimately, the decisions of the Section Editor are binding and conclusive.

The condition for publication of the manuscript is to read and send the following documents originally signed by all authors of the manuscript to editorial office:

1. publishing agreement (2 copies),
2. open access license (1 copy),
3. checklist – research reporting (Guidelines for research reporting),

Additionally, scanned version of these documents should be uploaded on the editorial platform together with scan of the relevant Ethics Committee in the case of research conducted on humans.

Rules for editing articles

1. **Original, review and case studies** are published in a bilingual version (in Polish and English) in case of authors of Polish nationality. In case of the rest authors – only in English.
2. The volume of original articles should not exceed 6 pages, including a summary in Polish and English. Not including literature.
3. The length of review papers should not exceed 9 pages, including a summary in Polish and English. Not including literature.
4. The volume of case reports should not exceed 6 pages, including a summary in Polish and English. Not including literature.
5. Reviews of books, doctoral dissertations, as well as texts containing reports from congresses, conferences and seminars important for nursing science and practice are also published. The volume of these texts should not exceed 3 pages, including references. Language of publication: optionally Polish or English.
6. The articles should be written in the Word text editor, Times New Roman font size „12”, 1.5 spaces.
7. Proposals for emphasis should be highlighted in the text in bold.
8. The place for printing the tables and figures should be marked in the text in bold.
9. **The title page** should be prepared in a **separate file** (the title page should not be combined with the manuscript file). The title page **should contain**:
 1. **full title of the article** in Polish and English;
 2. **short title of the article** in Polish and English;
 3. **full name(s) and surname(s) of the Author(s)** of the article and **ORCID number**;
 4. **the full name of the center(s)** in Polish and English from which the article comes (in the officially established version); in the case of multi-center article, please assign the authors to the institution they represent;
 5. indicate **the author for correspondence** and **the institutional correspondence address**;
 6. name and surname of the person or name of the company that **translated the text** into English;
 7. a description of any possible **conflicts of interest**; if the authors report no conflict of interest, they should add the following sentence: „The authors report no conflict of interest.”;
 8. information about **financing sources** (grant, sponsor);
 9. **additional information**: acknowledgments, possibly the name of the congress at which the article was announced and the patient's consent to publication, if required.

YOU SHOULD NOT INCLUDE A TITLE PAGE EITHER IN A SEPARATE FILE OR AS PART OF THE MANUSCRIPT ON THE PLATFORM. The above information is only necessary for submitting the article through the system.

We encourage authors to follow research reporting guidelines in submitted articles. The table below provides information on guidelines for different types of testing.

Abstract and key words

The article must be accompanied by an **abstract**, identical in **both Polish and English**. The summary of original papers, review papers and case studies should contain **200 words** and should consist of **four separate parts**, marked with the following titles: Purpose of the paper, Material and methods, Results, Conclusions. All **abbreviations** used in the summary should be explained. After the summary, no more than **5 key words should be placed in Polish and English**, consistent with the current list of Medical Subject Heading (MeSH).

Article arrangement

The article layout should include separate parts:

Introduction, Aim of the study, Material and methods (the Material and methods section must explain in detail all the research methods used that are included in the results, sample and instruments used; the names of the statistical methods and software used to prepare the results should be provided, ethical issues), Research results, Discussion, Conclusions, References, Tables, Figures.

Tables

Table titles and their contents should be in Polish and English (in separate tables). All abbreviations used in the tables should be explained below the table. Tables should be described above the table and numbered with Arabic numerals (Table 1) and formatted in black and white, in the Word text editor, in vertical orientation.

Figures

Figures should be described below the figure and numbered with Arabic numerals (Fig. 1) and formatted in black and white. All abbreviations used under the figure should be explained below the figure. Figures should be sent in an editable version.

Abbreviations and symbols

Only standard abbreviations and symbols should be used. A full explanation of a concept or symbol should precede the first use of its abbreviation in the text, and should also appear in the legend of each figure and table in which it is used.

References

The references should be arranged in accordance with the order in which the articles are cited in the text, tables and figures (in the case of items cited only in tables and figures, the order is consistent with the first reference to the table or figure in the text). The number of cited articles in the case of empirical research papers should not exceed 20 items, review papers should not exceed 40 items, and in the case of case studies - 10 items. The references should include only published items.

When bibliographic descriptions of articles from journals, please provide: author's surname and first name initial (if there are more than 4 authors, only the first three and the annotation „et al.” are provided); title of the article; abbreviation of the title of the journal (in accordance with the current list of journals indexed in Index Medicus), available, among others, at <https://www.ncbi.nlm.nih.gov/nlmcatalog?cmd=search>, year of publication, volume (year) number and page numbers where the article begins and ends, e.g.:

Descriptions of books should include: surname(s) of the author(s) with the initials of the name, title, possibly the next edition number, name of the publisher, place and year of publication; in collective papers, the name(s) of the responsible editor(s) is given in the book's subtitle and the abbreviation „(ed.)”, and when describing book chapters, the following should be given: Author(s) of the chapter, title of the chapter, then after the designation „[in:] ” the title of the whole, the Author(s) (Editor(s) of the whole), the name of the publishing part, the name of the publisher, the place and year of publication and the -page numbers on which the paper begins and ends, e.g.:

It is necessary **to use punctuation** strictly in accordance with the above examples of bibliographic description.

Links to online publications are permitted only in the absence of adequate data in published literature. When using electronic information sources, the full website address and the date of use are required

Copyrights and obligations

Detailed copyrights and obligations are specified in the publishing agreement.

Changing the order of authors is acceptable only in exceptional and justified cases. To change the order of authors before publication of the article (and/or add an author), please complete and send the Authorship reorder form to the editorial office.

After accepting the article for printing and before printing it, the Author should pay a fee of PLN 500.00 or EUR 110 (including VAT) to the account:
